## **BNAT Program Description**

The Nursing Assistant program is designed to prepare individuals to administer patient care as members of a nursing team in hospitals, nursing homes, home health agencies, and other extended care facilities. The nursing assistant course consists of 5 weeks program of 120 hours consisting of theory, laboratory and clinical content. The course is approved by the Illinois Department of Public Health. Successful completion of the NATCEP exam is required for employment as a Certified Nurse Assistant.

## **Program Objectives**

By the end of the program/course, the student will demonstrate 21 clinical basic skills through a combination of lecture, Lab and supervised clinical experiences at long-term healthcare facility.

ACSI will train every enrolled student to gain knowledge in both clinical and didactic areas in the field of Basic Nurse Assistant. Upon successfully passing the program with 80% or higher and after passing the clinical practicum of the course, the student will receive a certificate of competition. Student will also be eligible to sit for the State licensure Exam.

Students are required to pass the Illinois State Certification Exam for Certified Nursing Aide to work as such in the state of Illinois. For more information, please visit the Illinois Nurse Aide Testing website. Please visit INAT website for the latest exam certification information.

- Must possess a minimum of eight grade completion
- Be at least 16 years of age or be a high school graduate from an accredited high school or certified General Education Degree (GED) completer.
- Assigned attestation verifying proof of high school diploma or GED is also accepted as proof of meeting requirements at the time of enrollment for NA applicants
- Students must be able to produce original Social Security Card as well as current State Identification card/International Passport.
- Applicants must adhere to a physical examination (TB test).
- Accumulative health record is completed by the student and returned to the school.
- An IDPH Criminal Background Check and child abuse history clearance is required as all documentation must be submitted prior to the first week of class. The cost is covered by student.
- All students are required to carry health insurance or sign a waiver assuming responsibility for all health care costs in which they may incur.
- Fees for all health care costs solely lie at the responsibility of the student.
- Must have sound English speaking skills.

The Certified Nurse Assistant /Nurse Aide program is based on the principle of competency-based education which requires that each graduate attain a minimal level of competency in performing the duties of an entry-level nurse aide / certified nursing assistant. The Certified Nursing Assistant program is completed in 5 Weeks.

A) Part 1 is the “Course Outline” 80 clock hours of classroom training:

80 clock hours of classroom training (defined as classroom and skills training which does not involve direct care of residents by trainees)

The breakdown of class hours per Section of the Curriculum is listed below. (Note that the first 16 hours (Section I) are required hours and content that must be taught prior to any direct contact with a resident. The hours for the remaining Sections are suggested by the committee, and can be altered as needed, if the total 80 hours are met.):

Section I – Introduction 16 required hours\*

Section II – Personal Care Skills 24 suggested hours

Section III – Basic Nursing Skills 16 suggested hours

Section IV – Restorative Services 16 suggested hours

Section V – Mental Health & Social Service Needs 8 suggested hours Total

### Cancelation and refund Policies

When a student gives a written notice of cancellation, Amazing Care Systems Inc. shall provide a refund in the amount of at least the following:

1. An applicant not accepted by the school shall receive a refund of all moneys paid
2. A student will receive a full refund of all moneys paid, including registration fees, tuition, and all other charges, regardless of whether or not the student has started training, as long as he or she gives a written notice of cancellation to the school within 5 business days of the initial date of enrollment. The date of cancellation is determined by the postmark or by the date the written notification is hand- delivered to the school.
3. When written notice of cancellation is given after the fifth business day following enrollment, but before completion of student's first day of class, the school may retain no more than \$50 application fee plus the cost of any materials which have been provided by the school and retained by the student.
4. When notice of cancellation is given after the student's completion of the first day of class but prior to the student's completion of 5% of the course, the school will retain the \$50 application fee, the cost of any books and supplies used and/or retained by the student.
5. When the student has completed more than 5% of the course, ACSI will retain the \$50.00 application fee, the cost of books and supplies provided to the student, and a percentage of then instructional (tuition) charges according to the following table. Please see table below:-
6. The school shall mail a written acknowledgement of a student's cancellation or written withdrawal to the student within 15 calendar days of the date the student notified the school of his or her withdrawal.
7. Any refund owed to the student upon his or her cancellation will be made within 30 calendar days from the date of the student's written notice of cancellation.
8. The unexplained absence of a student from school for more than 7 consecutive days shall be considered withdrawal from the school. The cancellation date shall be the last day of attendance. Students who do not return from a leave of absence will be terminated from the program using the documented date of return as the termination date.
9. Any student withdrawal from the program is entitled to an official transcript of all hours completed.
10. If ACSI cancels a course, the enrolled student shall receive a full refund of all monies paid to the school.
11. If the course is cancelled after the student has begun instruction or if the school closes permanently and ceases to offer instruction after a student has enrolled, full refund will be returned to the student.

### SCHOOLS REFUND POLICY

1. When notice of cancellation is given before 5:00pm of the fifth business day after the date of enrollment, but One week prior to the first day of class, all fees minus the registration processing fee shall be refunded to the student.
2. Should a student's enrollment be terminated after the start of class or less than one week prior the course beginning, the student will be entitled to a prorated refund?
3. Refunds shall be based on when written notice of cancellation from the student is submitted.
4. Applicants not accepted by the school shall receive a refund of all tuition and fees paid within 30 calendar days after the determination of non-acceptance is made. The refund amount will show the nonrefundable registration fee of \$50.00 deducted.
5. Deposits or down payments shall become part of the tuition.
6. The school shall mail a written acknowledgement of a student's cancellation or written withdrawal to the student within 15 calendar days of the postmark date of notification. Such written acknowledgement is not necessary if a refund has been mailed to the student within the 15 calendar days.
7. A student's refunds shall be made by the school within 30 calendar days from the date of receipt of the student's cancellation.
8. **The student's registration, textbook, Lab fee, and CPR are non-refundable expenses.**
9. A school shall refund all monies paid to it in any of the following circumstances:
  - A) The school did not provide the prospective student with a copy of the student's valid enrollment agreement and a current catalogue or bulletin;
  - B) The school cancels or discontinues the course of instruction in which he student has enrolled;
  - C) The school fails to conduct classes on days or times scheduled, detrimentally affecting the student.
